

CONDITIONS OF ENTRY TO CHAIRMAN'S

In addition to The Star Gold Coast's Terms of Entry, the following conditions of entry apply:

- Subject to condition 5, access to Chairman's is open to eligible Members of The Star Club and their eligible guests, that have become Members of The Star Club, and is by invitation only. The Star Gold Coast may, in its absolute discretion, grant, suspend or revoke access at any time.
- 2. Presentation of a valid Membership Card is a condition of entry but does not guarantee entry. You must swipe your Membership Card on entering Chairman's and you must produce your Membership Card when requested.
- 3. Patrons applying to access Chairman's will be subject to, and must first pass, customer screening checks undertaken by The Star Gold Coast. Further screening checks may be undertaken on patrons by The Star Gold Coast from time to time and on more than one occasion. Without limiting condition 1 above, your access to Chairman's may be removed or revoked, if The Star Gold Coast is either not able to complete its screening checks on you, is not satisfied with the outcome of its screening check or is otherwise prohibited from providing you with access.
- 4. Gambling within Chairman's is restricted to Members of The Star Club only.
- 5. All non-Members of The Star Club granted access to Chairman's are not permitted to gamble in Chairman's and must be accompanied by an employee of The Star Gold Coast at all times whilst within Chairman's.
- 6. You are responsible for the actions and behaviours of each of your eligible partners and guests who access Chairman's and your guests may only remain in Chairman's while you remain present with them.
- 7. Illegal and undesirable activity will not be tolerated. Without limiting the generality of the above, the following conduct is not permitted in Chairman's:
 - Fighting or assault
 - Theft or attempted theft, vandalism, unauthorised possession or removal of property
 - Engaging in transactions involving the proceeds of crime, either receiving, possessing, concealing or disposing of the proceeds of crime
 - Lending money for profit or soliciting funds or monies from another guest
 - Possession of firearms or other dangerous weapons
 - Procurement and solicitation for purposes of prostitution
 - Entering or remaining in Chairman's whilst intoxicated
 - Indecent or abusive language towards staff or other guests
 - Rude and discourteous behaviour towards staff or other guests
 - Bullying and all other forms of harassment towards staff and other guests
 - Dealing or use of prohibited drugs or the abuse of prescription or over the counter drugs

- Disregard of the applied dress standards
- Bringing a minor into Chairman's
- Cheating or attempting to cheat at the gaming tables, electronic gaming tables or gaming machines
- Misuse of your access rights (e.g. allowing other persons to access Chairman's using your membership card)
- Misuse of guest passes
- Abuse of complimentary privileges including food and beverage offerings
- Any conduct or activity that may, in the absolute discretion of The Star Gold Coast, bring The Star Gold Coast into disrepute
- 8. You must not disclose any information about a Member of The Star Club to another Casino Operator or third party, nor are you permitted to act as a representative of another Casino Operator and/or solicit or refer Members of The Star Club to another Casino Operator or third party.
- 9. The Star Gold Coast may amend these conditions of entry at any time by displaying the new conditions of entry at the entry to Chairman's.
