The following Promotion Details are to be read in conjunction with the Terms and Conditions.

Promotion Details	
Item 1: Promoter	The Promoter is The Star Entertainment Qld Limited ABN 78 010 741 045 trading as The Star Gold Coast, Broadbeach Island, Broadbeach, Queensland 4218, (07) 5592 8100 (the “Promoter”).
Item 2: Promotion	Sovereign Mega – August 2024 (the “Promotion”).
Item 3: Participating Property	The Star Gold Coast
Item 4: Promotion Period	The Promotion Period is from 12:00am on Monday 29 July until the conclusion of the 7.00pm draw on Sunday 25 August 2024. All times are listed in Australian Eastern Standard Time.
Item 5: Entry Requirement	Participation in the Promotion is open to all persons who satisfy clause 2 of the Terms and Conditions of this Promotion, and who are a select Diamond, Platinum, Prestige Gold, Prestige Platinum or Prestige Diamond tier member of The Star Club with an active membership card (each an “Eligible Entrant”). For the avoidance of doubt, entrants who: <ul style="list-style-type: none"> a. migrate to a higher membership tier during the Promotion Period will remain an “Eligible Entrant” so long as they: <ul style="list-style-type: none"> I. hold a Diamond, Platinum, Prestige Gold, Prestige Platinum or Prestige Diamond tier The Star Club membership or higher for the duration of the Promotion Period, and II. have a valid Diamond, Platinum, Prestige Gold, Prestige Platinum or Prestige Diamond tier The Star Club membership at the time of Entering the Promotion; b. relegate to a membership tier which is lower than Platinum or Prestige Gold tier The Star Club membership at any time during the Promotion Period, will be an “Invalid Entrant” and will no longer be eligible to enter or participate in the Promotion and will forfeit any entitlement to a prize.

<p>Item 10: Present at Draws</p>	<p>Eligible Entrants can <u>activate</u> Entries into the Draws by having an open rating during the time of a Draw by playing in Oasis, Sovereign or Chairmans on any compatible electronic gaming machine, electronic table game or table game, excluding poker, with their membership card inserted or provided to the croupier.</p> <p><u>To be “Present at the Relevant Prize Draws”:</u></p>

Item 14: Other conditions	<p><u>No substitutions, transfers, replacement or gift receipts/exchanges</u></p> <p>Prizes cannot be substituted and are not transferrable. Once a prize has been accepted by the prize winner, The Star Gold Coast will not replace damaged, lost or stolen prizes. The Star Gold Coast will not provide gift receipts for prizes won or in any way facilitate exchanges with suppliers for prizes won. The Promoter reserves the right to review and utilise all property resources available, including security and CCTV footage, if a Member is suspected for fraudulent or undesirable use of a Membership Card that calls into question the validity of any prize won.</p>

Terms and Conditions

1. The Promoter listed in **Item 1** will conduct the Promotion listed in **Item 2** at the Participating Property listed in **Item 3** during the Promotion Period listed in **Item 4**.
2. Participation in the Promotion is open to all persons who meet and continue to satisfy throughout the

Promotion Period the details listed in Item 5 as well as the following requirements:

- a. 18 years of age or older;
- b. entitled to access the Draw Location;
- c. not excluded (including an exclusion direction or self-exclusion order) from a casino or premises operated by The Star Entertainment Group Limited (and its related entities); and

- d. not the subject of a Withdrawal of License (**WOL**) from The Star Sydney, The Star Gold Coast or Treasury Brisbane.
3. If an Eligible Entrant: (i) has their membership status cancelled or otherwise amended; (ii) is excluded from a casino or premises operated by The Star Entertainment Group Limited (and its related entities); or (iii) is issued a Withdrawal of License (**WOL**) from The Star Sydney, The Star Gold Coast or Treasury Brisbane:

(b) prior to that person claiming the relevant prize (if the Eligible Entrant is a selected winner),

12. The Promoter accepts no responsibility for late or non-received Entry/Entries. The Promoter does not guarantee the continuous or fault-free operation of the entry processes, including entry validating and receiving processes, during the Promotion.
13. In the event that a malfunction occurs with Synkros system, the Promoter will extract from the Synkros system all virtual entries earned in accordance with these Terms and Conditions and the draw process will be conducted manually.
14. The Promoter reserves the right to waive or vary the identification requirements specified in these Terms and Conditions in circumstances where the identity of the winner is determinable without the assistance of the specified identification.
15. Any entrant who tampers, or attempts to tamper, with the entry processes or tampers, or attempts to tamper with the processes used for the draws or who submits an entry which is not valid in accordance with these terms will be subject to disqualification at the discretion of the Promoter.
16. Entrants may be asked to participate in publicity or advertising at the request of the Promoter.
