Item 3: Participating Property	The Star Gold Coast
Item 4: Promotion Period	The Promotion Period is from 12:00am on Monday 29 July until the conclusion of the 7.00pm draw on Sunday 25 August 2024.

- 3. If an Eligible Entrant: (i) has their membership status cancelled or otherwise amended; (ii) is excluded from a casino or premises operated by The Star Entertainment Group Limited (and its related entities); or (iii) is issued a Withdrawal of License (WOL) from The Star Sydney, The Star Gold Coast or Treasury Brisbane:
  - (a) during the Promotion; or
  - (b) prior to that person claiming the relevant prize (if the Eligible Entrant is a selected winner),
