The Tournament Manager (the licensed person appointed by the Promoter with responsibility for overall control of the Tournament) may alter the starting time of any Tournament Session if reasonable notice (at least 20 minutes) has been given to Contestants.

Eligible Entrants

Participation in the Tournament is limited to persons who are for the duration of the Tournament Period:

- a. aged 18 years or over;
- b. a member of The Star Club with a valid membership card ("Card");
- not excluded (including an exclusion direction or self-exclusion order) from a casino or premises operated by The Star Entertainment Group Limited or its related entities;
- d. not the subject of a Withdrawal of License (WOL) from The Star Sydney, The Star Gold Coast or Treasury Brisbane;
- e. entitled to enter the casino at The Star Sydney and gamble;
- f. not an Invalid Entrant:
- g. not a director, officer, manager or employee of The Star Entertainment Group Limited or any of its related entities (including the Promoter); and
- h. not an immediate family member (including a sibling, parent, child, grandparent, grandchild, spouse, former spouse, de facto partner, or former de facto partner, including a step-relation and an adoptive relation) of any person listed in item (g) above or of their spouse, former spouse, de facto partner or former de facto partner,

("Eligible Entrants").

"Invalid Entrant" means an entrant who is not an "Eligible Entrant" for the duration of the Tournament Period. Invalid Entrants are not, or will no longer be, eligible to enter or participate in the Tournament and will forfeit any entitlement to a Prize.

Entry

Registration

There is no entry fee.

To participate in the Tournament (an "Entry"), an Eligible Entrant must present their Card at the designated registration desk located on the Main Casino Floor near the Tournament Location from 4:00pm AEST [until at least thirty (30) minutes prior to the start of the Tournament Session] on a Tournament Day and provide a signed Application Form (see below) to the Tournament Manager

("Contestant/s").

Contestants cannot register for a Tournament Session:

• before 4:00pm (AEST) on the applicable Tournament Day

Once a Contestant has successfully registered for a Tournament Session, they will receive a printed ticket ("Registration Receipt") which details their allocated Tournament Session and a 6-digit Personal Identification Number ("PIN").

The Promoter is not responsible for any lost, stolen or damaged Registration Receipts or PINs. If a Contestant's Registration Receipt or PIN is lost, stolen or damaged, the Contestant will not be entitled to participate in the Tournament Session.

The Promoter may refuse any application to register for a Tournament Session.

Withdrawal and non-attendance

Once an Eligible Entrant has registered for a Tournament Session, they cannot withdraw their Entry unless they confirm their withdrawal with the Tournament Manager at the Tournament Location [at least thirty (30) minutes prior to the start of the Tournament Session]. A financial penalty will not be imposed for withdrawals.

If a registered Eligible Entrant fails to present themselves at the Tournament Location at the start of a Tournament Session for which they are registered or is absent during a Tournament Session, they will forfeit any entitlement to participate in the Tournament Session or win a Prize. All entries are non-transferable.

Entry Limit

Contestants may only register for one (1) Tournament Session per Tournament Day.

Conduct of the Tournament

Tournament structure

The Tournament will be conducted on Halo Rapid Fusion Hybrid electronic table games.

The minimum number of Contestants required to conduct a Tournament Session is five (5). The Star Sydney may cancel a Tournament Session if the minimum number of Contestants do not enter the Tournament Session.

The maximum number of Contestants required to conduct a Tournament Session is thirty-six (36), with thirty-six (36) Tournament machines active. The Tournament will be open to a maximum of nine thousand, three hundred and sixty (9,360) Contestants.

The Star Sydney will assign Tournament machines on a 'first in, first served' basis prior to the commencement of the Tournament Session.

A Contestant must take their place at their assigned Tournament machine and enter their PIN to activate "Tournament mode" on the Tournament machine within five (5) minutes of the start of the Tournament Session.

In each Tournament Session, Contestants will start with a score of one hundred and fifty thousand (150,000) play-credits ("Tournament Credits").

Each Tournament Session will consist of fifteen (15) consecutive spins. It is not compulsory to place a wager on each spin. All spins (regardless of whether the Contestant places a wager on the spin) will count towards their fifteen (15) spins.

Each Tournament Session will run for twenty-five (25) minutes.

At the end of each Tournament Session, a Contestant's total number of Tournament Credits for that Tournament Session will be calculated and recorded by the Rapid Fusion Hybrid System ("RFH System"). A board will display the Contestant player allocated number with the highest total number of Tournament Credits for that Tournament Session, as recorded by the RFH System ("Leaderboard").

All Contestants will be limited to 30 seconds per spin to place a wager ("Allocated Betting Time"). The Allocated Betting Time will commence when the dealer indicates it is the Contestants' turn to act

After the Allocated Betting Time, the dealer will spin the ball. A Contestant cannot place a wager on a spin once the dealer has called no more bets.

Contestants must not advise, or seek advice from, other Contestants or persons not involved in the Tournament during play.

Wagers:

- a. All wagers will be made in the format of Tournament Credits. Tournament Credits are chips issued to Tournament players for the purposes of wagering and scoring in the Tournament. Tournament Credits have no cash value and are not redeemable for cash or any other type of chips or benefit
- b. Only Tournament Credits available on the Tournament machine may be wagered.
- c. A Contestant may only wager from their allocated Tournament machine.
- d. A spin indicator may be used to indicate the spin number.
- e. Only wagers placed before the dealer declares no more bets will be valid.
- f. A maximum wager per spin of ten thousand (10,000) Tournament Credits applies.
- g. If a wager is placed on a spin, the minimum wager is five hundred (500) Tournament Credits.

Prize

The total Prize pool value for the Tournament Period is up to \$90,000 in Entertainment Credits.

The total Prize pool value for each Tournament Day is up to \$1,500 in Entertainment Credits.

Each Prize is \$300 in Entertainment Credits.

Contestants are able to win more than one (1) Prize during the Tournament Period (but cannot win more than one Prize per Tournament Session).

Entertainment Credits refer to a choice of Casino Dollars or Food and Non-Alcoholic Beverage Vouchers. If the Prize Winner chooses Casino Dollars as their Prize, they will forfeit 10% of their eligible Prize value.

Casino Dollars are valid for one hundred and eighty (180) days from the Contestant's last recorded rating. Casino dollars will be credited to the Prize Winner's membership account within forty-eight (48) hours of the end of the Tournament Period. Food and Non-Alcoholic Beverage Vouchers are valid for one hundred and eighty (180) days from the date of issue, and will be issued in denominations of \$50 and \$100. Food & Non-Alcoholic Beverage Vouchers will be credited to the Prize Winner's membership account within forty-eight (48) hours of the end of the Tournament Period. Vouchers can be redeemed on food and non-alcoholic beverages at selected outlets owned by the Promoter, subject to outlet opening hours and availability. Excludes special events and public holidays. Vouchers are not redeemable for cash and any unused portion is non-refundable after the expiry of the Voucher. Vouchers cannot be used to pay for alcoholic beverages. Vouchers can be used in conjunction with other member benefits and discounts.

Prize Determination

At the conclusion of each Tournament Session, the Contestant with the highest number of Tournament Credits on the Leaderboard will win a Prize ("Winner").

If two (2) or more Contestants jointly have the highest number of Tournament Credits ("Joint Winners"), the Prize will be split (so far as practical) evenly amongst the Joint Winners, so as not to exceed the total Prize pool available for that Tournament Session.

To claim the Prize, a Winner must visit The Star Club Desk and present a Valid ID which is acceptable to the representative of the Promoter by 11:59pm (AEST) on the same Tournament Day.

Valid ID means:

- a passport, Australian driver's licence or other form of photographic identification in which the
 photograph is clear and undamaged and that is otherwise acceptable to the Promoter; or
- two forms of non-photographic identification that are valid and acceptable to the Promoter.

In the event of an invalid Entry, the forfeited or returned Prize will instead be awarded to the Contestant with the next highest (or equal highest if there were Joint Winners) number of Tournament Credits at the conclusion of the Tournament Session. Any Invalid Entrant will forfeit and if applicable, must return any Prize.

If at the time a Prize Winner is to receive a Prize, that person is excluded (including under an exclusion direction, an exclusion order or a self-exclusion order) from a casino or premises operated by The Star Group or is the subject of a Withdrawal of License from a casino or premises operated by The Star Group, their Entry will be deemed an Invalid Entry and will be disqualified and that person will not receive the Prize.

General Terms and Conditions

- The Tournament is conducted by The Star Sydney in accordance with these General Terms and Conditions and the Rules of the Game for Rapid Fusion Hybrid Electronic Table Game (Roulette Component) at The Star Sydney. A copy of the Rules of the Game can be found at https://www.star.com.au/sydney/sites/star.com.au.sydney/files/rapid fusion hybrid electronic table game rules.pdf. These General Terms and Conditions incorporate and must be read together with the details outlined in the table above and with the Rules of the Game. By entering this Tournament, you accept these General Terms and Conditions. In the event of any inconsistency between these General Terms and Conditions and the Rules of the Game, the Rules of the Game prevail.
- 2 The Star Club Terms and Conditions also apply. A copy can be found at https://www.thestarclub.com.au/terms-conditions.
- 3 Your Entry must be received as described in the table above and is subject to the Entry limits and eligibility requirements stated in these Terms and Conditions. Your Entry is deemed to be received only when received by the Promoter. If your Entry is based on participation that is deemed invalid, or if your membership status is cancelled or otherwise amended so that you are no longer an Eligible Entrant, your Entry into the Tournament will be deemed invalid.
- 4 If, at the time of a draw/tournament, a person is restricted or prevented from entering the casino area due to a 'temporary prevention of entry' for contravention of a Playbreak rule, that person is not eligible to claim a prize (even if they are the selected winner) and that person will forfeit any entitlement to a prize.
- The Promoter is not liable for any problems with communications networks. You are responsible for your own costs associated with entering the Tournament. If you enter using multiple aliases/addresses/email addresses/phone numbers you may be disqualified.
- Where relevant, it is your responsibility to open or close your rating by asking the Dealer/Games Supervisor to open or close your rating at any eligible table game, or to remove your card from the machine or game.
- 7 The Promoter reserves the right to waive or vary the identification requirements specified in these Terms and Conditions in circumstances where the identity of the Prize winner is determinable without the assistance of the specified identification.
- 8 If you or your Entry are deemed by the Promoter to breach these Terms and Conditions, your Entry (or at the Promoter's discretion, all of your entries if you have multiple entries) will be voided.
- The Promoter may, at any time, require you to produce documentation to establish to the Promoter's satisfaction the validity of your Entries (including documentation establishing your identity, age, place of residence and place of employment). Failure by the Promoter to enforce any of its rights at any stage does not waive those rights.

10 You must not:

- a. tamper with the Tournament's Entry process;
- b. engage in any conduct that may jeopardise the fair and proper conduct of the Tournament;
- c. act in a disruptive, annoying, threatening, abusive or harassing manner directly or indirectly in relation to the Tournament;

- e. breach any law; or

- 11 The Promoter is not liable for Entries, prize claims or correspondence that are, due to factors outside its reasonable control, misplaced, misdirected, delayed, lost, incomplete, illegible or incorrectly submitted.
- 12 In the event of a dispute relating to these Terms and Conditions, the Promoter's decision is final. Where any person is not satisfied with a decision of the Promoter relating to this Tournament, the person may lodge a complaint with an inspector under section 33 of the Gaming and Liquor Administration Act 2007 (NSW).
- 13 The Promoter may cancel or change any Prize offered under the Tournament if there are any changes to the law which would or might render the Tournament or any Prize offered under the Tournament unlawful.
- 14 The Prize values are correct as at the date of preparing these Terms and Conditions and include any applicable GST. The Promoter is not responsible for any change in Prize value. You agree that if a Prize (or element of a Prize) is unavailable for any reason the Promoter may provide another item of equal or higher value, subject to any necessary approval by any regulatory authority.

- 15 If the Promoter determines that the integrity of the Tournament has been compromised it may, subject to notifying the relevant regulatory authority, either postpone the Tournament or any Tournament Session until such a time as the integrity of the Tournament has been validated or cancel the Tournament or any compromised Tournament Session.
- To the extent that a situation, malfunction, or other issue arises for which these Terms and Conditions make no provision or in relation to which the relevant terms and conditions are unclear, the Promoter reserves the right to:
 - a. make a decision regarding those circumstances which is not inconsistent with these Terms and Conditions; and/or
 - b. postpone the Tournament or any Tournament Session to a time and place which will allow the Tournament or the Tournament Session to be conducted in accordance with all Terms and Conditions other than those Terms and Conditions which specify the time and place of the Tournament or Tournament Session.
- 17 If this Tournament cannot run as planned for any reason beyond the Promoter's control, including but not limited to: act of god, law, public health order, pandemic, software, hardware or communications issues, unauthorised intervention, tampering, fraud or technical failure, the Promoter may end, change, suspend or cancel the Tournament or disqualify affected entries/entrants, subject to any necessary approval by a regulatory authority.
- 18 The Promoter may in any event cancel the Tournament without liability. In that case the Promoter will refund all entry fees.
- 19 The Promoter may disclose your personal information, including details of Prize winners where required or authorised to do so by or under law or the disclosure is reasonably necessary to enforce the law. This may occur under the laws that apply to the Promoter's business, for example, where a regulatory authority requests information from the Promoter.
- The Promoter is not responsible for any tax implications arising from you winning a prize. You should seek independent financial advice. If for GST purposes this Tournament results in any supply being made for non-monetary consideration, you must follow the Australian Taxation Office's stated view that where the parties are at arm's length, goods and services exchanged are of equal GST inclusive market values.

- 23 In these Terms and Conditions, the word "including" and any similar words are not words of limitation.
- Nothing in these Terms and Conditions restricts, excludes or modifies any consumer rights under any statute including the Competition and Consumer Act 2010 (Cth).
- 25 Subject to the previous paragraph, the Promoter and the agencies and companies associated with this Tournament are not liable (including in negligence) for any loss (including indirect, special or consequential loss or loss of profits), expense, damage, personal injury, illness or death suffered in connection with this Tournament or any Prize (including the use of any Prize), except for any liability which under statute cannot be excluded (in which case that liability is limited to the greatest extent allowed by law).
- 26 Without limiting paragraph 25, the Promoter and the agencies and companies associated with this Tournament are not liable for:
 - a. any loss of, damage to or delay in delivery of Prizes; or
 - b. any damage that occurs to Prizes if/when displayed at the Promoter's premises,

to the extent those things are due to factors outside the Promoter's reasonable control.

- 27 The Promoter needs to collect the personal information of each entrant so that the entrant can be entered into the Tournament. The Promoter will use entrants' personal information to conduct and manage the Tournament. The Promoter may disclose entrants' personal information to its related companies, agents and contractors to assist in conducting this Tournament and to communicate with entrants.  - a. the purposes for which The Star Entertainment Group, including the Promoter, may collect, store, use and disclose entrants' personal information;
 - b. how entrants can seek access to the personal information the Promoter holds about them and request changes to it; and
 - c. how entrants can complain about a privacy breach and how the Promoter will deal with such a complaint.
