## Terms and Conditions **Gold Mega – October 2024**

Item 2: Promotion	Gold Mega – October 2024 (the "Promotion").
Item 3: Participating Property	The Star Gold Coast
Item 4: Promotion Period	The Promotion Period will run from 12.00am on Monday 16 September 2024 until the conclusion of the 3.00pm draw on Sunday 20 October 2024.
	All times are listed in Australian Eastern Standard Time.
Item 5: Entry Requirement	Participation in the Promotion is open to all persons who satisfy clause 2 of the Terms and Conditions of this Promotion, and who are a select Gold tier member of The Star Club with an active membership card (each an "Eligible Entrant").

#### The Star Club

The Promoter reserves the right to review and utilise all property resources available, including security and CCTV footage, if a Member is suspected for fraudulent or undesirable use of a Membership Card that calls into question the validity of any prize won.
