The following Promotion Details are to be read in conjunction with the Terms and Conditions.

Item 1: Promoter	The Promoter is The Star Entertainment Brisbane Operations Pty Ltd ABN 98 608 159 173 of 33 William Street, Brisbane QLD 4000. (the "Promoter").
Item 2: Promotion	Oasis Mega – September 2024 (the "Promotion").
Item 3: Participating Property	The Star Brisbane
Item 4: Promotion Period	The Promotion Period will run from 12.00am on Friday 30 August 2024 until the conclusion of the 8.45pm Draw on Sunday 29 September 2024.
	All times are listed in Australian Eastern Standard Time.
Item 5: Entry Requirement	Participation in the Promotion is open to all persons who satisfy clause 2 of the Terms and Conditions of this Promotion, and who are a select Gold tier Member of The Star Club with an active Membership Card (each an "Eligible Entrant").
	For the avoidance of doubt, entrants who:

The Promoter reserves the right to review and utilise all property resources available, including security and CCTV footage, if a Member is suspected for fraudulent or undesirable use of a Membership Card that calls into question the validity of any prize won.

- 12. The Promoter accepts no responsibility for late or non-received Entry/Entries. The Promoter does not guarantee the continuous or fault-free operation of the entry processes, including entry validating and receipting processes, during the Promotion.
- 13. In the event that a malfunction occurs with Synkros system, the Promoter will extract from the Synkros system all virtual entries earned in accordance with these Terms and Conditions and the Draw process will be conducted manually.
- 14. The Promoter reserves the right to waive or vary the identification requirements specified in these Terms and Conditions in circumstances where the identity of the winner is determinable without the assistance of the specified identification.
