

Terms and Conditions

Schedule

"Promotion"	Melbourne Cup Sports Bar Draw – November 2024
"Promoter"	The Star Pty Limited (ABN 25 060 510 410) trading as "The Star Sydney" of 80 Pyrmont Street, Pyrmont NSW 2009.
"Promotional Period"	The Promotion commences at 12:00pm AEDT on Tuesday, 5 November 2024 and concludes at 4:30pm AEDT on Tuesday, 5 November 2024.
"Eligible Entrants"	Only persons who are, for the duration of the Promotional Period:
	a. aged 18 years or over;
	b. residents of Australia;
	 not excluded (including an exclusion direction, an exclusion order or a self-exclusion order) from a casino or premises operated by The Star Entertainment Group Limited (ABN 85 149 629 023) or its related entities (collectively, "The Star Group");
	 d. not the subject of a Withdrawal of License from a casino or premises operated by The Star Group;
	e. not a director, officer, manager, employee or contractor of any of The Star Group entities; and
	f. not an immediate family member (including a sibling, parent, child, grandparent, grandchild, spouse, former spouse, de facto partner or former de facto partner, including a step-relation and an adoptive relation) of any person listed in paragraph (f) above or of their spouse, former spouse, de facto partner or former de facto partner,
	("Eligible Entrants").
	A person who does not satisfy any of the criteria for an "Eligible Entrant" for the duration of the Promotional Period is an "Invalid Entrant" and their Entry will be deemed invalid ("Invalid Entry").
	An entrant who is a member of The Star Club and requests to cancel their membership prior to, or during, the Promotional Period will also be an Invalid Entrant.
	Invalid Entrants are not, or will no longer be, eligible to enter or participate in the Promotion and will forfeit any entitlement to a Prize.
"Entry"	All Eligible Entrants who dine at either BLACK Bar and Grill, Cucina Porto or Harvest Buffet for lunch between 12:00pm AEDT and 3:00pm AEDT on Tuesday, 5 November 2024 will be given a draw card with a unique number attached. They will be automatically entered into the draw taking place in Sports Bar at 4:30pm AEDT on Tuesday, 5 November 2024. Eligible Entrants must:
	(a) be inside Sports Bar at 4:30pm for the draw;(b) have their draw card with them
Entry Limit	Each Eligible Entrant is limited to 1 Entry during the Promotional Period.

"Prize"	The prize is a Chandon Hamper (" Prize ") valued at AU \$500.
	The Promoter will not permit Prizes to be transferred, or redeemed or exchanged for cash.
"Prize Determination"	The Promoter will conduct the Prize draw ("Prize Draw") at 4:30pm AEDT on Tuesday 5 November, 2024.
	The Prize Draw will be conducted using a <i>physical barrel</i> ("Barrel") at Sports Bar ("Draw Location").
	The first Entry randomly drawn from the Barrel in the Prize Draw will win the Prize and the Eligible Entrant who submitted the Entry will be a drawn entrant ("Drawn Entrant").
	Eligible Entrants <i>are</i> required to be present at the Draw Location for each Prize Draw in order to win a Prize.
	The Promoter may, in its reasonable discretion taking into account these Terms and Conditions, deem an Entry to be an Invalid Entry and disqualify such an Entry, including the following:
	(a) an Entry from an Invalid Entrant;

	Invalid Entries are not eligible to win a Prize. If a person with an Invalid Entry is awarded a Prize inadvertently, they must return it to the Promoter immediately upon request.



Notification of Prize Winner/s

The name of the Drawn Entrant will be announced on the public address system at the Draw Location.

The Promoter does not guarantee that all Prize Draw announcements will be audible and understandable in all parts of the Draw Location at all times.

To claim a Prize, the Drawn Entrant must present themselves to a representative of the Promoter at the Draw Location within four (4) minutes of their name being announced ("Standard Presentation Period") as timed by the clock displayed at the Draw Location.

The Drawn Entrant must then produce within four (4) minutes of the expiry of the Standard Presentation Period their Valid ID that is acceptable to the representative of the Promoter ("Prize Winner").

Valid ID means:

- a passport, Australian driver's licence or other form of photographic identification in which the photograph is clear and undamaged and that is acceptable to the Promoter; or
- b. two forms of non-photographic identification that are valid and acceptable to the Promoter.

The results of the Prize Determination will not be published, unless otherwise stated in these Terms and Conditions.

If, despite its reasonable efforts, the Promoter cannot locate the Prize Winner or confirm a Prize Winner within the four (4) minute period, the Prize Winner forfeits the Prize and is no longer the Prize Winner for the purposes of these terms and conditions.

If the Prize Winner forfeits the Prize, the Promoter will conduct another Prize Draw ("Second Judging"). If required, the Second Judging will take place at the venue by 3:50pm the same day. The Promoter will take reasonable efforts to notify the Prize Winner as a result of the Second Judging in venue immediately after the Second Judging. If for any reason the Judges cannot reasonably locate a prize winner, this manner of judging will continue until a prize winner is found.

Terms and Conditions

- These Terms and Conditions incorporate and must be read together with the details set out in the Schedule above. By entering this Promotion, you are confirming that you accept these Terms and Conditions.
- Your Entry into this Promotion must be received during the Promotional Period and is subject to Entry limits and eligibility requirements. Your Entry is deemed to be received only when received by the Promoter's database. If your Entry is based on participation that is reversed, cancelled or otherwise deemed invalid, or if your membership status is cancelled or otherwise amended so that you are no longer an Eligible Entrant, your Entry into the Promotion may be deemed invalid at the Promoter's discretion. - Where relevant for instant win promotions, printing and other quality control errors outside the Promoter's control will not invalidate an otherwise valid Prize claim. Liability

- Subject to the previous paragraph, the Promoter and the agencies and companies associated with this Promotion are not liable (including in negligence) for any loss (including indirect, special or consequential loss or loss of profits), expense, damage, personal injury, illness or death suffered in connection with this Promotion or any Prize, except for any liability which under statute cannot be excluded (in which case that liability is limited to the greatest extent allowed by law).
