| <b>Item 1: Promoter</b>               | The Promoter is The Star Entertainment Brisbane Operations Pty Ltd ABN 98 608 159 173 of 130 William Street, Brisbane QLD 4000.   |
| <b>Item 2: Promotion</b>              | Spin to Win at Sports Bar.  |
| <b>Item 3: Participating Property</b> | The Star Brisbane located at 33 William Street, Brisbane QLD 4000.  |
| <b>Item 4: Promotion Period</b>       | The Promotion Period is from 2.30pm on Saturday 28 September until the conclusion of the draws on Sunday 6 October, 2024 which is expected to conclude by 9.30pm.<br><br>All times referred to throughout these Terms and Conditions are listed in Australian Eastern Standard Time.  |
| <b>Item 5: Entry Requirement</b>      | Participation in the Promotion is open to all persons who satisfy clause 2 of the Terms and Conditions of this Promotion (each an “ <b>Eligible Entrant</b> ”).   |

|                                    | <p>Each Wristband Entry has a unique entry number (“<b>Entry Number</b>”) and that same Entry Number is printed on both the Wristband and the Entry Ticket. The Wristband must remain intact and worn on the Eligible Entrant’s wrist to remain valid (“<b>Valid Wristband</b>”).</p> <p>The Promoter supports the responsible service of alcohol and the Promotion is at all times subject to the Promoter’s responsible service of alcohol policy. The entitlement of Eligible Entrants to receive a Wristband Entry is subject at all times to the Promoter’s policies and legal obligations in relation to the responsible service of alcohol. | <p><b>Item 8: Draw Details</b></p> | <p>Draws will occur on Saturday 28 September 2024 and on Sunday, 6 October 2024 (each draw referred to as a “<b>Draw</b>” and each day referred to as a “<b>Draw Day</b>”).</p> <p>The Draw on Saturday, 28 September 2024 is referred to as the “<b>AFL Grand Final Draw</b>” and the draw on Sunday, 6 October 2024 is referred to as the “<b>NRL Grand Final Draw</b>”.</p> <p>The AFL Grand Final Draw will occur on Saturday, 28 September 2024 following the completion of the AFL Grand Final match (including any overtime) and after the grand final trophy presentations have occurred.</p> <p>While the exact time of the AFL Grand Final Draw cannot be provided as it is dependent on when the AFL Grand Final match completes and the trophy presentations have occurred (as described above), it is expected that the Draw will occur between 6pm and 7pm on the Draw Day (noting that the exact time will vary).</p> <p>The NRL Grand Final Draw will occur on Sunday, 6 October 2024 following the completion of the NRL Grand Final match (including any form of overtime) and after the grand final trophy presentations have occurred.</p> <p>While the exact time of the NRL Grand Final Draw cannot be provided as it is dependent on when the NRL Grand Final match completes and the trophy presentations have occurred (as described above), it is expected that the Draw will occur between 8.30pm and 9.30pm on the Draw Day (noting that the exact time will vary).</p> <p>At each Draw, six (6) Entry Tickets will be drawn from the Barrel (subject to Item 12 Redraws).</p> <p>The Promoter will announce the Entry Number on each Entry Ticket that is drawn from the Barrel at the Draw Location.</p> <p>An Eligible Entrant wearing the corresponding Valid Wristband bearing the same Entry Number as the drawn Entry Ticket (“<b>Selected Eligible Entrant</b>”) will be deemed a “<b>Selected Winner</b>”, provided that they also satisfy all requirements of these Terms and Conditions including Item 5, Item 10 and Item 13.</p> |

| <p><b>Item 12:</b> Redraw/s</p>           | <p>If a Selected Eligible Entrant is deemed “Not Present at the Relevant Draw” as set out in Item 10, or does not otherwise satisfy all requirements of these Terms and Conditions in order to be eligible to be deemed a Selected Winner, redraws of Entry Tickets will occur until a Selected Eligible Entrant is identified that satisfies all requirements of these Terms and Conditions, including Item 10, and can therefore be deemed a Selected Winner.</p> <p>If an Eligible Entrant who satisfies the requirements of these Terms and Conditions is not identified after conducting two (2) consecutive redraws to identify a Selected Winner, then the number of persons to be deemed Selected Winners under these Terms and Conditions may be reduced by one. The reduction in number of Selected Winners may occur each time there are two (2) consecutive redraws. | <p><b>Item 14:</b> Other conditions</p>   | <p>Wristbands are only valid for the Draw Day on which they are issued.</p> <p>The Barrel will be emptied at the conclusion of each Draw Day.</p> <p>Removed, damaged or misplaced Wristbands will not be replaced.</p> <p>Any individual who has received more than one Wristband on a Draw Day is ineligible to enter or participate in the Draw occurring on that Draw Day. If such individual’s corresponding Entry Ticket is drawn, then such Entry Ticket is deemed invalid and a Redraw will occur in accordance with Item 12.</p> <p>All Selected Winners that win a prize must sign a “prize log” confirming the prize they have won.</p>  |

## Terms and Conditions

1. The Promoter listed in **Item 1** will conduct the Promotion listed in **Item 2** at the Participating Property listed in **Item 3** during the Promotion Period listed in **Item 4**.
2. Participation in the Promotion is open to all persons who meet and continue to satisfy throughout the Promotion Period the details listed in **Item 5** as well as the following requirements:
  - a. 18 years of age or older;
  - b. entitled to access the Draw Location;
  - c. not excluded (including an exclusion direction or self-exclusion order) from a casino or premises operated by The Star Entertainment Group Limited (and its related entities); and
  - d. not the subject of a Withdrawal of License (**WOL**) from The Star Sydney, The Star Gold Coast or The Star Brisbane.
3. If an Eligible Entrant: (i) has their membership status cancelled or otherwise amended; (ii) is excluded from a casino or premises operated by The Star Entertainment Group Limited (and its related entities); or (iii) is issued a Withdrawal of License (**WOL**) from The Star Sydney, The Star Gold Coast or The Star Brisbane:
  - (a) during the Promotion; or

12. The Promoter accepts no responsibility for late or non-received Entry/Entries. The Promoter does not guarantee the continuous or fault-free operation of the entry processes,

including entry validating and receipting processes, during the Promotion.

13. In the event that a malfunction occurs with Synkros system, the Promoter will extract from the Synkros system all virtual entries earned in accordance with these Terms and Conditions and the draw process will be conducted manually.
14. The Promoter reserves the right to waive or vary the identification requirements specified in these Terms and Conditions in circumstances where the identity of the winner is determinable without the assistance of the specified identification.
15. Any entrant who tampers, or attempts to tamper, with the entry processes or tampers, or attempts to tamper with the processes used for the draws or who submits an entry which is not valid in accordance with these terms will be subject to disqualification at the discretion of the Promoter.
