The following Promotion Details are to be read in conjunction with the Terms and Conditions.

	Promotion Details
Item 1: Promoter	The Promoter is The Star Entertainment Qld Limited ABN 78 010 741 045 trading as The Star Gold Coast, Broadbeach Island, Broadbeach, Queensland 4218, (07) 5592 8100 (the "Promoter").
Item 2: Promotion	'Bauble Bonanza': November - December 2024 (the "Promotion").
Item 3: Participating Property	The Star Gold Coast
Item 4: Promotion Period	The Promotion will commence at 4.00pm on Wednesday 13 November 2024 and will end at the conclusion of the 6.40pm draw on Friday 20 December 2024.
	All times are listed in Australian Eastern Standard Time (AEST) unless otherwise specified.
Item 5: Entry Requirement	Participation in the Promotion is open to all persons who satisfy clause 2 of the Terms and Conditions of this Promotion, and who are a Selected Member of The Star Club with an active membership card (each an "Eligible Entrant").
Item 6: Entry Period	An Eligible Entrant does not need to generate or earn entries in order to enter this promotion.

The Promoter reserves the right to announce the first name and membership number of the drawn Eligible Entrant at other locations at the Participating Property (other than the Draw Location). Resort Voucher Prizes (Comp Dollars) may become temporarily unavailable at any time, outside of the control of the Promoter.

Resort Voucher Prizes (Comp Dollars) will expire if at least one (1) Tier Point is not accrued at least once every 90 days.

Casino Dollars

Casino Dollar Prizes will load directly to the relevant Member's account. Casino Dollars may become temporarily unavailable at any time, outside of the control of the Promoter.

Casino Dollars will expire if at least one (1) Tier Point is not accrued at least once every 180 days.

No substitutions, transfers, replacement or gift receipts/exchanges

Prizes cannot be substituted and are not transferrable.

Terms and Conditions

- 12. The Promoter accepts no responsibility for late or non-received Entry/Entries. The Promoter does not guarantee the continuous or fault-free operation of the entry processes, including entry validating and receipting processes, during the Promotion.
- 13. In the event that a malfunction occurs with Synkros system, the Promoter will extract from the Synkros system all virtual entries earned in accordance with these Terms and Conditions and the draw process will be conducted manually.
- 14. The Promoter reserves the right to waive or vary the identification requirements specified in these Terms and Conditions in circumstances where the identity of the winner is determinable without the assistance of the specified identification.
- 15. Any entrant who tampers, or attempts to tamper, with the entry processes or tampers, or attempts to tamper with the processes used for the draws or who submits an entry which is not valid in accordance with these terms will be subject to disqualification at the discretion of the Promoter.
