Item 1: Promoter	The Promoter is The Star Entertainment Brisbane Operations Pty Ltd ABN 98 608 159 173 of 33 William Street, Brisbane QLD 4000. (the “Promoter”).

Item 3: Participating Property	The Star Brisbane
Item 4: Promotion Period	<p>The Promotion Period is from 4:00pm on Monday 4 November 2024 until the conclusion of the 6.57pm Draw on Tuesday 26 November 2024.</p> <p>All times are listed in Australian Eastern Standard Time.</p>
Item 5: Entry Requirement	<p>Participation in the Promotion is open to all persons who satisfy clause 2 of the Terms and Conditions of this Promotion, and who are a select Gold tier Member of The Star Club with an active Membership Card (each an “Eligible Entrant”).</p> <p>For the avoidance of doubt, entrants who:</p> <ul style="list-style-type: none">a. migrate to a higher membership tier during the Promotion Period will remain an “Eligible Entrant” so long as they:<ul style="list-style-type: none">I. hold a Gold tier The Star Club membership or higher for the duration of the Promotion Period, andII. held a valid Gold tier The Star Club membership at the time of Entering the Promotion;b. relegate to a membership tier which is lower than Gold tier The Star Club membership during the Promotion Period, will be an “Invalid Entrant” and will no longer be eligible to enter or participate in the Promotion and will forfeit any entitlement to a prize.

The Star Brisbane will not provide gift receipts for prizes won or in any way facilitate exchanges for prizes won.</p> <p><u>Casino Dollars</u> Casino Dollar Prizes will load directly to the Member’s account. Casino Dollars may become temporarily unavailable at any time due to reasons outside of the control of the Promoter such as technical or system issues. Casino Dollars will expire if at least one (1) Tier Point is not accrued at least once every 180 days.</p> <p><u>The Star Club</u> Any Member found to be in breach of The Star Club Membership terms and conditions of use, including participation or knowledge of fraudulent activity such as purposely participating with another Members Membership Card, is subject to consequences determined by The Promoter and The Star Club terms and conditions. The Promoter reserves the right to review and utilise all property resources available, including security and CCTV footage, if a Member is suspected for fraudulent or undesirable use of a Membership Card that calls into question the validity of any prize won.</p>

Terms and Conditions

1. The Promoter listed in **Item 1** will conduct the Promotion listed in **Item 2** at the Participating Property listed in **Item 3** during the Promotion Period listed in **Item 4**.
2. Participation in the Promotion is open to all persons who meet and continue to satisfy throughout the Promotion Period the details listed in **Item 5** as well as the following requirements:
 - a. 18 years of age or older;
 - b. entitled to access the Draw Location;
 - c. not excluded (including an exclusion direction or self-exclusion order) from a casino or premises operated by The Star Entertainment Group Limited (and its related entities); and
 - d. not the subject of a Withdrawal of License (**WOL**) from The Star Sydney, The Star Gold Coast or The Star Brisbane.

If an Eligible Entrant: (i) has their membership status cancelled or otherwise amended; (ii) is excluded from a casino or premises operated by The Star Entertainment Group Limited (and its related entities); or (iii) is issued a Withdrawal of License (WOL) from The Star Sydney, The Star Gold Coast or The Star Brisbane:

13. The Promoter reserves the right to waive or vary the identification requirements specified in these Terms and Conditions in circumstances where the identity of the winner is determinable without the assistance of the specified identification.
14. Any entrant who tampers, or attempts to tamper, with the entry processes or tampers, or attempts to tamper with the processes used for the Draws or who submits an entry which is not valid in accordance with these terms will be subject to disqualification at the discretion of the Promoter.
