The following Promotion Details are to be read in conjunction with the Terms and Conditions.

Item 2: Promotion	Sovereign Mega – November 2024 (the "Promotion").
Item 3: Participating Property	The Star Gold Coast
Item 4: Promotion Period	The Promotion Period is from 12:00am on Monday 28 October 2024 until the conclusion of the 7.00pm draw on Sunday 24 November 2024.
	All times are listed in Australian Eastern Standard Time.
Item 5: Entry Requirement	Participation in the Promotion is open to all persons who satisfy clause 2 of the Terms and Conditions of this Promotion, and who are a select Diamond, Platinum, Prestige Gold, Prestige Platinum or Prestige Diamond tier member of The Star Club with an active membership card (each an "Eligible Entrant").
