

Terms and Conditions
Trivia Tuesday

The following Promotion Details are to be read in conjunction with the Terms and Conditions.

Item 1: Promoter	The Promoter is The Star Entertainment Brisbane Operations Pty Ltd ABN 98 608 159 173 of 130 William Street, Brisbane QLD 4000.
Item 2: Promotion	Trivia Tuesday at Sports Bar.
Item 3: Participating Property	The Star Brisbane located at 33 William Street, Brisbane QLD 4000.
Item 4: Promotion Period	The Promotion Period is from 7.00pm until 8.30pm on Tuesday 15 October, 2024. All times referred to throughout these Terms and Conditions are listed in Australian Eastern Standard Time.
Item 5: Entry Requirement	Participation in the Promotion is open to all persons who satisfy clause 2 of the Terms and Conditions of this Promotion (each an “ Eligible Entrant ”). Employees, management and directors (“ Staff Members ”) of The Star Entertainment Group (“ TSEG ”) are permitted to participate in the Promotion and are considered “ Eligible Entrants ” with the exception that they, and their team (as referred to in Item 7) are ineligible to receive a Prize. Therefore, any Eligible Entrant who is not a Staff Member is also ineligible to win a Prize in this Promotion if the Eligible Entrant is a member of the same team (as referred to in Item 7) as a Staff Member. By participating in this Promotion, all Eligible Entrants (whether they are Staff Members or non-Staff Members) acknowledge and understand the conditions of this Item 5.
Item 6: Entry Period	During the Promotional Period, an Eligible Entrant may take part in a trivia competition held at the following times: Competition one (1): from 7:00pm to 8:30pm on Tuesday 15 October, 2024 (each a “ Competition ”)
Item 7: Method of Entry	To enter the Promotion an Eligible Entrant must enter a Competition. To enter a Competition, Eligible Entrants must: a) attend Sports Bar at the commencement of a Competition (the Promoter recommends arriving at least 10 minutes prior to the commencement of a Competition); b) form a team consisting between one (1) to eight (8) Eligible Entrants; c) register their team name and number of team members with the trivia host prior to the commencement of a Competition in order to receive an answer sheet; d) work with their team to answer a series of trivia questions on various topics provided by the trivia host within the time allowed by the trivia host (approximately 60 seconds). Each team must write their answers on the answer sheet provided to

Teams will earn points for correct answers to trivia questions;</p> <p>e) submit their team’s answer sheet to the trivia host at the end of the Competition as directed by the trivia Host. Answer sheets will not be accepted 3 minutes after Trivia Host requests all answer sheets be returned to them;</p> <p>f) as referred to in Item 8 below, the team with the most points at the end of the Competition will win First Prize, the team with the second highest points total will win Second Prize and the team with the third highest points total will win Third Prize.</p> <p>An Eligible Entrant may only enter themselves and their team once per Competition. The Promoter takes no responsibility for late, lost or misdirected entries. Incomplete, illegible or incomprehensible entries will be deemed invalid.</p> <p>During a Competition, your team must answer the questions supplied by the trivia host on your answer sheet and you must return your answer sheet at the conclusion of the Competition to the trivia host as directed.</p> <p><u>This is a game of skill and chance plays no part in the determination of the winner.</u></p> <p>Eligible Entrants may join only one team during the Promotional Period.</p>
<p>Item 8: Prize Determination</p>	<p>For each Competition, the team with the most points accumulated from correct answers to trivia questions will win a \$150 Sports Bar Voucher (“First Prize”). The team with the second most points accumulated from correct answers to trivia questions will win a \$100 Sports Bar Voucher (“Second Prize”). The team with the third most points accumulated from correct answers to trivia questions will win a \$50 Sports Bar Voucher (“Third Prize”).</p> <p>For the avoidance of doubt the Prizes are given to the team as a whole to be shared by that team’s members, and not on an individual basis.</p> <p>Sports Bar Vouchers are subject to the voucher terms and conditions outlined on the voucher itself.</p> <p>As referred to in Item 5 above, if any Staff Members participate in the Promotion, then they and their team (including any Eligible Entrants who are non-Staff Members) are ineligible to win or receive a Prize.</p> <p>The panel of Judges will consist of one (1) trivia host. The winning teams of each Competition (Prize Winner/s) will be the team with the highest score, second highest score and third highest score as determined by the Judge in their absolute discretion. The Judge’s decision is final, and no correspondence will be entered. The Judges will select three (3) Prize Winner/s at approximately 8:30pm on Tuesday 15 October, 2024.</p> <p>If two or more teams tie, the trivia host will continue with a series of tie-breaker questions until one team is deemed a Prize Winner.</p>
<p>Item 9: Promotion Location</p>	<p>Sports Bar – The Star Brisbane.</p>
<p>Item 10: Present at the Judging</p>	<p>Prize Winners will be announced live in the venue by 8:45pm on the day of judging. If, despite its reasonable efforts, the Promoter cannot locate the Prize Winner or confirm a Prize Winner by 8:45pm on the respective night of the Judging, the Prize Winner forfeits the Prize and is no longer the Prize Winner for the purposes of these terms and</p>

In this event Item 12 will apply.</p> <p>In the event that a team has finished in a position which would otherwise be eligible for a prize but for the fact that a Staff Member is a participant on that team, then the trivia host will announce that team is ineligible for a Prize and then proceed to award the relevant Prize to the next eligible team (being a team without any Staff Member participants).</p>

<p>Item 12: Second Judging</p>	<p>If the Prize Winner forfeits the Prize as set out in Item 10, the Judges will select the next highest scoring team of the Competition as the Prize Winner (“Second Judging”). If required, the Second Judging will take place at the venue by 9:00pm the same day. The Promoter will take reasonable efforts to notify the Prize Winner as a result of the Second Judging in venue immediately after the Second Judging. If for any reason the Judges cannot reasonably locate a Prize Winner, this manner of judging will continue until a Prize Winner is found.</p>	
	<p>Winning team members must produce Valid ID to a representative of the Promoter at the Promotion Location to confirm their eligibility, and their team’s eligibility, to be deemed a Prize Winner and win a prize. “Valid ID” means either:</p> <ul style="list-style-type: none"> a. a passport, Australian driver’s license or other form of photographic identification in which the photograph is clear and undamaged and that is otherwise acceptable to the Promoter; or b. one form of non-photographic identification that are valid and acceptable to the Promoter.

Terms and Conditions

1. The Promoter listed in **Item 1** will conduct the Promotion listed in **Item 2** at the Participating Property listed in **Item 3** during the Promotion Period listed in **Item 4**.
2. Participation in the Promotion is open to all persons who meet and continue to satisfy throughout the Promotion Period the details listed in **Item 5** as well as the following requirements:
 - a. 18 years of age or older;
 - b. entitled to access the Promotion Location;
 - c. not excluded (including an exclusion direction or self-exclusion order) from a casino or premises operated by The Star Entertainment Group Limited (and its related entities); and
 - d. not the subject of a Withdrawal of License (**WOL**) from The Star Sydney, The Star Gold Coast or The Star Brisbane.
3. If an Eligible Entrant: (i) has their membership status cancelled or otherwise amended; (ii) is excluded from a casino or premises operated by The Star Entertainment Group Limited (and its related entities); or (iii) is issued a Withdrawal of License (**WOL**) from The Star Sydney, The Star Gold Coast or The Star Brisbane:
 - (a) during the Promotion; or
 - (b) prior to that person claiming the relevant prize (if the Eligible Entrant is a selected winner),so that he or she no longer satisfies **Condition 2**, that person will no longer be eligible to enter or participate in the Promotion and/or claim a prize (even if they are the selected winner) and that person will forfeit any entitlement to a prize.

To the extent that a situation or issue arises for which these Terms and Conditions make no provision for or a situation or issue arises to which the relevant Terms and Conditions are unclear, the Promoter reserves the right to make a decision regarding such situation or issue which is not inconsistent with these Terms and Conditions.
10. The Promoter accepts no responsibility for late or non-received registrations. The Promoter does not guarantee the continuous or fault-free operation of the registration processes, including entry validating and receipting processes, during the Promotion.
11. In the event that a malfunction occurs with Synkros system, the Promoter will extract from the Synkros system all virtual entries earned in accordance with these Terms and Conditions and the draw process will be conducted manually (If applicable).
12. The Promoter reserves the right to waive or vary the identification requirements specified in these Terms and Conditions in circumstances where the identity of the winner is determinable without the assistance of the specified identification.

13. Any entrant who tampers, or attempts to tamper, with any registration processes or tampers, or attempts to tamper with any processes used throughout the Promotion or who submits a registration which is not valid in accordance with these terms will be subject to disqualification at the discretion of the Promoter.
14. Entrants may be asked to participate in publicity or advertising at the request of the Promoter. Participation in any such publicity or advertising is at the sole discretion of the relevant Entrant.
