Item 4: Promotion Period	<p>The Promotion Period is from 12:00am Sunday 1 December 2024 and ends at the conclusion of the 8:45pm Draw on Wednesday 26 February 2025.</p> <p>All times are listed in Australian Eastern Standard Time.</p>
Item 5: Entry Requirement	Participation in the Promotion is open to all persons who satisfy clause 2 of the Terms and Conditions of this Promotion, who are Members of The Star Club or Prestige Domestic program operated by the Promoter and that have a current Membership Card. (each an "Eligible Entrant").
Item 6a: Earning Period – Jackpot Draws	<p>During the Promotion Period, an Eligible Entrant can generate an entry (each an "Entry") between the following times:</p> <p>From 12.00am on Sunday 1 December 2024 until 7.59pm on Wednesday 26 February 2025.</p> <p>(the "Entry Period").</p>
Item 6b: Entry Period - Minor Draws	To be eligible to be selected in a Minor Draw an Eligible Entrant must be playing a compatible electronic gaming machine, electronic table game (an "Eligible Machine") or Table Game (an "Eligible Table") excluding The Star Brisbane Tournament Omaha or Texas Hold'em Poker shown in Item 7b with a valid Membership Card at the Draw Location shown in Item 9 at the time of a Random Selection Draw shown in Item 8b .

	<p>i) 8.40pm</p> <p>(Each a “Minor Draw”).</p> <p>At each Minor Draw, the name and Membership Card number of the first (1st) valid Eligible Entrant drawn by a representative of the Promoter will be announced at the Draw Location.</p> <p>The Promoter reserves the right to announce the name and Membership number of Eligible Entrant/s at various locations at the Participating Property (including the Draw Location). The Promoter cannot guarantee that all announcements can be heard at the Draw Location or in all parts of the Participating Property.</p> <p>The Eligible Entrant does not need to present to claim their Prize.</p>
<p>Item 9: Draw Locations</p>	<p>The Star Brisbane</p>
<p>Item 10: Present at Draws</p>	<p><u>To be “Present at the Relevant Prize Draws”:</u></p> <p>To be eligible to claim a Prize, each Eligible Entrant who is drawn and has their name announced in accordance with Items 8a, must present themselves to a representative of the Promoter at any customer services desk or to the Draw Location within four (4) minutes of their name being announced and provide suitable identification.</p> <p>If a drawn Eligible Entrant has presented themselves to a representative of the Promoter, the representative will inform the promotions host at the Draw Location that a drawn Eligible Entrant has presented themselves and a drawn Eligible Entrant will have ten (10) minutes from this time to make their way to the Draw Location and confirm their identity. <p>Item 11: Prize/s</p>	<p><u>Minor Prizes</u></p> <p>Each Selected Winner at each Minor Draw will win:</p> <p>a) \$250 Casino Dollars</p> <p>(each a “Minor Prize”).</p> <p>There are a total of nine (9) Minor Prizes to be won on each Wednesday in the Promotion Period (each a “Draw Day”).</p> <p>The total Minor Prize Pool each Draw Day is \$2,250 Casino Dollars. The total Minor Prize Pool for the Promotion is \$27,000 Casino Dollars.</p>

	<p>Jackpot Draw The Selected Winner at each Jackpot Draw will either win the Minimum Prize or the Jackpot Value. <p>Item 12: Redraw/s</p>	<p><u>“Not present at the relevant Draw”</u></p> <p>If the drawn Eligible Entrant of a Jackpot Draw does not present to the Draw location within the time limit listed in Item 10, no redraws will take place.</p> <p>The Promoter will add \$2,500 to the Jackpot Value to be won at the next Jackpot Draw (“Jackpot Value”). This process will occur at each Jackpot Draw until an eventual winner is found.</p> <p>On the Final Draw Day (Wednesday 26 February, 2025) if the Eligible Entrant of a Jackpot Draw does not present to the Draw location within the time limit listed in Item 10 or does not otherwise satisfy these Terms and Conditions, redraws will take place for Eligible Entrants with an existing Entry who have a Valid Open Rating at the time of the redraw until a Selected Winner is identified.</p>
<p>Item 13: Identification</p>	<p>A Selected Winner must produce Valid ID to a representative of the Promoter to confirm their eligibility to win a prize.</p> <p>“Valid ID” means:</p> <ul style="list-style-type: none"> a) a passport, Australian driver’s licence or other form of photographic identification in which the photograph is clear and undamaged and that is acceptable to the Promoter; or b) two forms of non-photographic identification that are valid and acceptable to the Promoter. <p>The Promoter reserves the right to waive or vary the identification requirements at its sole discretion in circumstances where the identity of a winner is determinable by a representative of the Promoter without the assistance of these or any other form of identification.</p>
<p>Item 14: Other conditions</p>	<p><u>No substitutions, transfers, replacement or gift receipts/exchanges</u> Prizes cannot be substituted and are not transferrable. Once a prize has been accepted by the prize winner, the Promoter will not replace damaged, lost or stolen prizes. The Promoter will not provide gift receipts for prizes won or in any way facilitate exchanges with suppliers for prizes won. Replacement of faulty, broken or damaged prizes will be at the discretion of the supplier and subject to their terms and conditions.</p> <p><u>Casino Dollars</u> Casino Dollar Prizes will load directly to the Member’s account. Casino Dollars may become temporarily unavailable at any time, outside of the control of the Promoter such as technical issues.</p> <p>Casino Dollars will expire if at least one (1) Tier Point is not accrued at least once every 180 days.</p>

The Star Club

Any Member found to be in breach of The Star Club membership terms and conditions of use, including participation or knowledge of fraudulent activity such as purposely participating with another Member's Membership Card, may be deemed ineligible for this promotion and the Promoter reserves all of its rights under these Terms and Conditions and under The Star Club membership terms and conditions. The Promoter reserves the right to review and utilise all property resources available, including security and CCTV footage, if a Member is suspected for fraudulent or undesirable use of a Membership Card that calls into question the validity of any prize won.

Terms and Conditions

1. The Promoter listed in **Item 1** will conduct the Promotion listed in **Item 2** at the Participating Property listed in **Item 3** during the Promotion Period listed in **Item 4**.
2. Participation in the Promotion is open to all persons who meet and continue to satisfy throughout the Promotion Period the details listed in **Item 5** as well as the following requirements:
 - a. 18 years of age or older;
 - b. entitled to access the Draw Location;
 - c. not excluded (including an exclusion direction or self-exclusion order) from a casino or premises operated by The Star Entertainment Group Limited (and its related entities); and
 - d. not the subject of a Withdrawal of License (**WOL**) from The Star Sydney, The Star Gold Coast or The Star Brisbane.
3. If an Eligible Entrant: (i) has their membership status cancelled or otherwise amended; (ii) is excluded from a casino or premises operated by The Star Entertainment Group Limited (and its related entities); or (iii) is issued a Withdrawal of License (**WOL**) from The Star Sydney, The Star Gold Coast or The Star Brisbane:

12. The Promoter accepts no responsibility for late or non-received Entry/Entries. The Promoter does not guarantee the continuous or fault-free operation of the entry processes, including entry validating and receipting processes, during the Promotion.
13. In the event that a malfunction occurs with Synkros system, the Promoter will extract from the Synkros system all virtual entries earned in accordance with these Terms and Conditions and the Draw process will be conducted manually.
14. The Promoter reserves the right to waive or vary the identification requirements specified in these Terms and Conditions in circumstances where the identity of the winner is determinable without the assistance of the specified identification.

15. Any entrant who tampers, or attempts to tamper, with the entry processes or tampers, or attempts to tamper with the processes used for the Draws or who submits an entry which is not valid in accordance with these terms will be subject to disqualification at the discretion of the Promoter.
