<b>Tournament Period</b>	This Tournament commences at 3:00pm (AEDT) on Monday, 2 December 2024 and concludes at 7:00pm (AEDT) on Tuesday 24 December, 2024.																																																												
<b>Tournament Location</b>	Sovereign Stadium area, Level 3 in the Sovereign Room at The Star Sydney, 80 Pyrmont Street, Pyrmont NSW 2009.

	<p>("Eligible Entrants").</p> <p>"Invalid Entrant" means an entrant who is not an "Eligible Entrant" for the duration of the Tournament Period. Invalid Entrants are not, or will no longer be, eligible to enter or participate in the Tournament and will forfeit any entitlement to a prize. Any Invalid Entrant who has paid an entry fee is not entitled to a refund of that entry fee.</p>
<b>Entry</b>	<p><b>Registration</b></p> <p>There is no entry fee.</p> <p>To participate in the Tournament, Eligible Entrants must present their Card and register with a signed Application Form (see below) at the designated registration desk/table in the Tournament Location ("<b>Registration Desk</b>") on a Tournament Day from 3:00pm (AEDT/AEST) during the Tournament Period.</p> <p>The Tournament Manager may require each Player to agree in writing with the Rules of the Game and these terms and conditions prior to entering into the Tournament.</p> <p>The Promoter may refuse any application to register for the Tournament, including if an Entry or entrant does not comply with these Terms and Conditions or the Rules of the Game.</p> <p>In the event of an Invalid Entry, any forfeited or returned Prize will instead be awarded to the Player with the next highest place and each subsequent Player in the lead will be elevated by one place.</p> <p>Once a contestant has successfully registered for a Tournament Session ("<b>Contestant</b>"), they will receive a printed ticket ("<b>Registration Receipt</b>") which details their allocated Tournament Session and a 6-digit Personal Identification Number ("<b>PIN</b>").</p> <p>The Promoter is not responsible for any lost, stolen or damaged Registration Receipts or PINs. If a Contestant's Registration Receipt or PIN is lost, stolen or damaged, the Contestant will not be entitled to participate in the Tournament Session.</p> <p>The Promoter may refuse any application to register for a Tournament Session.</p> <p><b>Withdrawal and non-attendance</b></p> <p>Once an Eligible Entrant has registered for a Tournament Session, they cannot withdraw their entry. If a registered Eligible Entrant fails to present themselves at the Tournament Location at the start of a Tournament Session or is absent during the Tournament Session, the Tournament Manager may:</p> <ul style="list-style-type: none"> <li>(a) direct the dealer to deduct an amount equal to the minimum wager for each coup for which the Eligible Entrant is absent, to a maximum of three rounds of play; or</li> <li>(b) declare that the Eligible Entrant will forfeit any entitlement to participate in the Tournament Session or win a Prize.</li> </ul> <p>All entries are non-transferable.</p>
<b>Entry Limit</b>	<p>Eligible Entrants can only register for one (1) Tournament Session per Tournament Day, and a total of two (2) Tournament Sessions per week during the Tournament Period.</p>
<b>Conduct of the Tournament</b>	<p><b>Tournament structure</b></p> <p>The Tournament will be conducted on Rapid Fusion Hybrid electronic table games.</p> <p>The minimum number of Contestants required to conduct a Tournament Session is five (5). The Star Sydney may cancel a Tournament Session if the minimum number of Contestants do not enter the Tournament Session.</p> <p>The maximum number of Contestants permitted to partake in a Tournament Session is thirty-three (33), with thirty-three (33) Tournament machines active. The Tournament will be open to a maximum of one thousand three hundred and twenty (1320) Contestants.</p>

The Star Sydney will assign Tournament machines on a 'first in, first served' basis prior to the commencement of the Tournament Session.

A Contestant must take their place at their assigned Tournament machine and enter their PIN to activate "Tournament mode" on the Tournament machine within five (5) minutes of the start of the Tournament Session.

In each Tournament Session, Contestants will start with a score of one hundred and fifty thousand (150,000) play-credits ("**Tournament Credits**").

Each Tournament Session will consist of fifteen (15) consecutive spins. It is not compulsory to place a wager on each spin. All spins (regardless of whether the Contestant places a wager on the spin) will count towards their fifteen (15) spins.

Each Tournament Session will run for twenty-five (25) minutes.

At the end of each Tournament Session, a Contestant's total number of Tournament Credits for that Tournament Session will be calculated and recorded by the Rapid Fusion Hybrid System ("**RFH System**"). A board will display the Contestant player allocated number with the highest total number of Tournament Credits for that Tournament Session, as recorded by the RFH System ("**Leaderboard**").

All Contestants will be limited to 30 seconds per spin to place a wager ("**Allocated Betting Time**"). The Allocated Betting Time will commence when the dealer indicates it is the Contestants' turn to act.

After the Allocated Betting Time, the dealer will spin the ball. A Contestant cannot place a wager on a spin once the dealer has called no more bets.

Contestants must not advise, or seek advice from, other Contestants or persons not involved in the Tournament during play.

**Wagers:**

- a. All wagers will be made in the format of Tournament Credits. Tournament Credits are chips issued to Tournament players for the purposes of wagering and scoring in the Tournament. Tournament Credits have no cash value and are not redeemable for cash or any other type of chips or benefit.
- b. Only Tournament Credits available on the Tournament machine may be wagered.
- c. A Contestant may only wager from their allocated Tournament machine.
- d. A spin indicator may be used to indicate the spin number.
- e. Only wagers placed before the dealer declares no more bets will be valid.
- f. A maximum wager per spin of ten thousand (10,000) Tournament Credits applies.
- g. If a wager is placed on a spin, the minimum wager is five hundred (500) Tournament Credits.

## General Terms and Conditions

- 1 The Tournament is conducted by The Star Sydney in accordance with these General Terms and Conditions and the Rules of the Game for Rapid Fusion Hybrid Electronic Table Game (Roulette Component) at The Star Sydney. A copy of the Rules of the Game can be found at [https://www.star.com.au/sydney/sites/star.com.au.sydney/files/rapid\\_fusion\\_hybrid\\_electronic\\_table\\_game\\_rules.pdf](https://www.star.com.au/sydney/sites/star.com.au.sydney/files/rapid_fusion_hybrid_electronic_table_game_rules.pdf). These General Terms and Conditions incorporate and must be read together with the details outlined in the table above and with the Rules of the Game. By entering this Tournament, you accept these General Terms and Conditions. In the event of any inconsistency between these General Terms and Conditions and the Rules of the Game, the Rules of the Game prevail.
- 2 The Star Club Terms and Conditions also apply. A copy can be found at <https://www.thestarclub.com.au/terms-conditions>.
- 3 Your Entry must be received as described in the table above and is subject to the Entry limits and eligibility requirements stated in these Terms and Conditions. Your Entry is deemed to be received only when received by the Promoter. If your Entry is based on participation that is deemed invalid, or if your membership status is cancelled or otherwise amended so that you are no longer an Eligible Entrant, your Entry into the Tournament will be deemed invalid.
- 4 If, at the time for collection of a Prize, a person is restricted or prevented from entering the casino area due to a 'temporary prevention of entry' for contravention of a Playbreak rule, that person is not eligible to claim a Prize (even if they are the selected winner) and that person will forfeit any entitlement to the Prize
- 5 The Promoter is not liable for any problems with communications networks. You are responsible for your own costs associated with entering the Tournament. If you enter using multiple aliases/addresses/email addresses/phone numbers you may be disqualified.
- 6 Where relevant, it is your responsibility to open or close your rating by asking the Dealer/Games Supervisor to open or close your rating at any eligible table game, or to remove your card from the machine or game.
- 7 The Promoter reserves the right to waive or vary the identification requirements specified in these Terms and Conditions in circumstances where the identity of the Prize winner is determinable without the assistance of the specified identification.
- 8 If you or your Entry are deemed by the Promoter to breach these Terms and Conditions, your Entry (or at the Promoter's discretion, all of your entries if you have multiple entries) will be voided.
- 9 The Promoter may, at any time, require you to produce documentation to establish to the Promoter's satisfaction the validity of your Entries (including documentation establishing your identity, age, place of residence and place of employment). Failure by the Promoter to enforce any of its rights at any stage does not waive those rights.
- 10 You must not:
  - a. tamper with the Tournament's Entry process;
  - b. engage in any conduct that may jeopardise the fair and proper conduct of the Tournament;
  - c. act in a disruptive, annoying, threatening, abusive or harassing manner directly or indirectly in relation to the Tournament;
  - d. do anything that may diminish the good name or reputation of the Promoter or any of its related entities or of the agencies or companies associated with this Tournament;
  - e. breach any law; or
  - f. behave in a way that is otherwise inappropriate or offensive directly or indirectly in relation to the Tournament.
- 11 The Promoter is not liable for Entries, prize claims or correspondence that are, due to factors outside its reasonable control, misplaced, misdirected, delayed, lost, incomplete, illegible or incorrectly submitted.
- 12 In the event of a dispute relating to these Terms and Conditions, the Promoter's decision is final. Where any person is not satisfied with a decision of the Promoter relating to this Tournament, the person may lodge a complaint with an inspector under section 33 of the Gaming and Liquor Administration Act 2007 (NSW).
- 13 The Promoter may cancel or change any Prize offered under the Tournament if there are any changes to the law which would or might render the Tournament or any Prize offered under the Tournament unlawful.

- 14 The Prize values are correct as at the date of preparing these Terms and Conditions and include any applicable GST. The Promoter is not responsible for any change in Prize value. You agree that if a Prize (or element of a Prize) is unavailable for any reason the Promoter may provide another item of equal or higher value, subject to any necessary approval by any regulatory authority.
- 15 If the Promoter determines that the integrity of the Tournament has been compromised it may, subject to notifying the relevant regulatory authority, either postpone the Tournament or any Tournament Session until such a time as the integrity of the Tournament has been validated or cancel the Tournament or any compromised Tournament Session.
- 16 To the extent that a situation, malfunction, or other issue arises for which these Terms and Conditions make no provision or in relation to which the relevant terms and conditions are unclear, the Promoter reserves the right to:
  - a. make a decision regarding those circumstances which is not inconsistent with these Terms and Conditions; and/or
  - b. postpone the Tournament or any Tournament Session to a time and place which will allow the Tournament or the Tournament Session to be conducted in accordance with all Terms and Conditions other than those Terms and Conditions which specify the time and place of the Tournament or Tournament Session.
- 17 If this Tournament cannot run as planned for any reason beyond the Promoter's control, including but not limited to: act of god, law, public health order, pandemic, software, hardware or communications issues, unauthorised intervention, tampering, fraud or technical failure, the Promoter may end, change, suspend or cancel the Tournament or disqualify affected entries/entrants, subject to any necessary approval by a regulatory authority.
- 18 The Promoter may in any event cancel the Tournament without liability. In that case the Promoter will refund all entry fees.
- 19 The Promoter may disclose your personal information, including details of Prize winners where required or authorised to do so by or under law or the disclosure is reasonably necessary to enforce the law. This may occur under the laws that apply to the Promoter's business, for example, where a regulatory authority requests information from the Promoter.
- 20 The Promoter is not responsible for any tax implications arising from you winning a prize. You should seek independent financial advice. If for GST purposes this Tournament results in any supply being made for non-monetary consideration, you must follow the Australian Taxation Office's stated view that where the parties are at arm's length, goods and services exchanged are of equal GST inclusive market values.
- 21 Should a Prize winner consent to having his/her photograph taken, that Prize winner consents to having his/her name and photograph published in any form of media and agrees to participate in any reasonable promotion requested by the Promoter.
- 22 Each Prize winner's name and/or their membership number will be published on a notice at the Tournament Location within 48 hours of the conclusion of the Tournament.

- 25 Nothing in these Terms and Conditions restricts, excludes or modifies any consumer rights under any statute including the Competition and Consumer Act 2010 (Cth).
- 26 Subject to the previous paragraph, the Promoter and the agencies and companies associated with this Tournament are not liable (including in negligence) for any loss (including indirect, special or consequential loss or loss of profits), expense, damage, personal injury, illness or death suffered in connection with this Tournament or any Prize (including the use of any Prize), except for any liability which under statute cannot be excluded (in which case that liability is limited to the greatest extent allowed by law).
- 27 Without limiting paragraph 26, the Promoter and the agencies and companies associated with this Tournament are not liable for:
