

Terms and Conditions
Event Centre Melbourne Cup Prize Draw

The following Promotion Details are to be read in conjunction with the Terms and Conditions.

Item 1: Promoter	The Promoter is The Star Entertainment Brisbane Operations Pty Ltd ABN 98 608 159 173 of 130 William Street, Brisbane QLD 4000.
Item 2: Promotion	Melbourne Cup Sweepstakes – Events Centre
Item 3: Participating Property	The Star Brisbane located at 33 William Street, Brisbane QLD 4000.
Item 4: Promotion Period	The Promotion Period is from 12.00pm on Tuesday 5 November, 2024 until the conclusion of the 2.05pm draw on Tuesday 5 November, 2024. All times referred to throughout these Terms and Conditions are listed in Australian Eastern Standard Time.
Item 5: Entry Requirement	Participation in the Promotion is open to all persons who are registered as attending the Melbourne Cup event at Event Centre at The Star Brisbane and also satisfy clause 2 of the Terms and Conditions of this Promotion (each an “ Eligible Entrant ”).
Item 6: Earning period	Eligible Entrants that satisfy the Method of Entry in Item 7 during 12.00pm until 1.45pm on Tuesday 5 November, 2024 (“ Entry Period ”).
Item 7: Method of Entry	Each Eligible Entrant will receive one (1) Entry Ticket (“ Entry Ticket ”) into the Draw by: <ul style="list-style-type: none"> (a) Registering their attendance for the Melbourne Cup Event at the Event Centre at The Star Brisbane by providing their booking details; (a) Filling out the Entry Ticket by writing their name and phone number clearly on the reverse side and; (b) placing their Entry Ticket into one (1) of the twenty-four (24) boxes that represent a horse running in the Melbourne Cup 2024 horse race. <p>Each Eligible Entrant is entitled to a maximum of one (1) Entry each.</p> <p>Eligible Entrants must place their Entry Ticket in one of the physical boxes by 1.45pm on the Draw Day. Entries cannot be placed in a box once the race has commenced.</p> <p>The Promoter supports the responsible service of alcohol and the Promotion is at all times subject to the Promoter’s responsible service of alcohol policy. The entitlement of Eligible Entrants to receive a Entry Ticket is subject at all times to the Promoter’s policies and legal obligations in relation to the responsible service of alcohol. The Promoter reserves the right to refuse service to a person or award an Entry Ticket to a person if to do so would be inconsistent with the Promoter’s responsible service of alcohol policy, or otherwise contrary to the Promoter’s legal obligations. For the avoidance of doubt, the Promoter’s rights to refuse service or to refuse to award an Entry Ticket as set out above prevail despite a person otherwise qualifying to be an Eligible Entrant.</p>
Item 8: Draw Details	Draws will occur on Tuesday 5 November, 2024 at 2:05PM following the completion of the Melbourne Cup race (referred to as a “ Draw Day ”). The Prize Draw (“ Prize Draw ”) will be conducted from all valid Entries submitted in accordance with Condition 5. A representative of the Promoter will then draw one Entry Ticket from each of the boxes that represent the 2024 Melbourne Cup first, second and third place winners (“ 2024 Melbourne Cup Place Winners ”), each a Selected Entrant (“ Selected Entrant ”).

	<p>A representative of the Promoter will review each drawn Entry Ticket and Selected Entrant to confirm eligibility into the Promotion. The Promoter reserves the right, at its sole and absolute discretion, to keep any irregular Entry Tickets, including the following ("Invalid Entries"):</p> <p>Entry Tickets produced by an Invalid Entrant; Entry Tickets placed in a numbered box that represents a horse scratched from the 2024 Melbourne Cup Race; Entry Tickets that are a duplicate Entry; Entry Tickets that appear to have been tampered with including Entry Tickets that have been teared or improperly applied; and Entry Tickets that are fraudulent or forged.</p> <p>An Eligible Entrant with an Invalid Entry is not entitled to participate in the promotion. If a Selected Entrant is deemed invalid or otherwise does not satisfy all requirements of these Terms and Conditions then they will not be deemed a Selected Winner and a Redraw will occur as set out in Item 12.</p> <p>For the avoidance of doubt, and subject to Item 12, there will be a maximum of three (3) Selected Winners.</p> <p>Drawn Eligible Entrants that satisfy these conditions of entry in Item 5 and Item 7 and otherwise satisfy the Terms and Conditions will be deemed a Selected Winner ("Selected Winner").</p> <p>The representative of the promoter will announce the names of the Selected Winners on the public address system in Event Centre. If the Selected Winner does not present themselves to claim their prize on the Draw Day, they will be contacted by a member of The Star Brisbane Marketing Team within twenty-four (24) hours confirming them as a Selected Winner and further instructions will be provided regarding how to claim their prize.</p> <p>The Promoter does not guarantee that all announcements will be audible and understandable in all parts of the Draw Location at all times. Eligible Entrants accept full responsibility for being able to hear and understand draw announcements.</p>

Item 12: Redraw/s	If a Selected Entrant does not otherwise satisfy all requirements of these Terms and Conditions in order to be eligible to be deemed a Selected Winner, redraws of Entry Tickets will occur until a Selected Entrant is identified that satisfies all requirements of these Terms and Conditions, and can therefore be deemed a Selected Winner.

Once a prize has been accepted by the prize winner, The Star Brisbane will not replace damaged, lost or stolen prizes. Terms and Conditions

1. The Promoter listed in **Item 1** will conduct the Promotion listed in **Item 2** at the Participating Property listed in **Item 3** during the Promotion Period listed in **Item 4**.
2. Participation in the Promotion is open to all persons who meet and continue to satisfy throughout the Promotion Period the details listed in **Item 5** as well as the following requirements:
 - a. 18 years of age or older;
 - b. entitled to access the Draw Location;
 - c. not excluded (including an exclusion direction or self-exclusion order) from a casino or premises operated by The Star Entertainment Group Limited (and its related entities); and
 - d. not the subject of a Withdrawal of License (**WOL**) from The Star Sydney, The Star Gold Coast or The Star Brisbane.
3. If an Eligible Entrant: (i) has their membership status cancelled or otherwise amended; (ii) is excluded from a casino or premises operated by The Star Entertainment Group Limited (and its related entities); or (iii) is issued a Withdrawal of License (**WOL**) from The Star Sydney, The Star Gold Coast or The Star Brisbane:

12. The Promoter accepts no responsibility for late or non-received Entry/Entries. The Promoter does not guarantee the continuous or fault-free operation of the entry processes,

including entry validating and receipting processes, during the Promotion.

13. In the event that a malfunction occurs with Synkros system, the Promoter will extract from the Synkros system all virtual entries earned in accordance with these Terms and Conditions and the draw process will be conducted manually.
14. The Promoter reserves the right to waive or vary the identification requirements specified in these Terms and Conditions in circumstances where the identity of the winner is determinable without the assistance of the specified identification.
15. Any entrant who tampers, or attempts to tamper, with the entry processes or tampers, or attempts to tamper with the processes used for the draws or who submits an entry which is not valid in accordance with these terms will be subject to disqualification at the discretion of the Promoter.
16. Entrants may be asked to participate in publicity or advertising at the request of the Promoter. Participation in any such publicity or advertising is at the sole discretion of the relevant Entrant.
