

Terms and Conditions

Sokyo Melbourne Cup Prize Draw

The following Promotion Details are to be read in conjunction with the Terms and Conditions.

| Item 1: Promoter | The Promoter is The Star Entertainment Brisbane Operations Pty Ltd ABN 98 608 159 173 of 130 William Street, Brisbane QLD 4000. |

| Item 4: Promotion Period | The Promotion Period is from 12.00pm on Tuesday 5 November, 2024 until the conclusion of the 2.05pm draw on Tuesday 5 November, 2024. |
| | All times referred to throughout these Terms and Conditions are listed in Australian Eastern Standard Time. |
| Item 5: Entry Requirement | Participation in the Promotion is open to all persons who are registered as attending the Melbourne Cup event at Sokyo at The Star Brisbane and also satisfy clause 2 of the Terms and Conditions of this Promotion (each an "Eligible Entrant"). |
| Item 6: Earning period | Eligible Entrants that satisfy the Method of Entry in Item 7 during 12.00pm until 1.15pm on Tuesday 5 November, 2024 ("Entry Period"). |
| Item 7: Method of Entry | Each Eligible Entrant will receive one (1) Entry Ticket ("Entry Ticket") into the Draw by: (a) Registering their attendance for the Melbourne Cup Event at Sokyo at The Star Brisbane by providing their booking details; (b) select a number between one (1) to twenty-four (24), each number corresponds to the Horse running in the Melbourne Cup 2024 Race; (c) this number must be written by the Eligible Entrant on the reverse of their Entry Ticket along with their name, phone number and email and; (d) providing their completed Entry Ticket to a representative of the Promoter by 1:15PM on the Draw Day. |
| | Each Eligible Entrant is entitled to a maximum of one (1) Entry each. A representative of the Promoter will place the entry in the numbered draw envelope ("Draw Envelope") that corresponds to the number selected by the Eligible Entrant Eligible Entrants must provide their Entry Ticket to a representative of the promoter by 1.15pm on the Draw Day. Entries will not be accepted once the race has commenced. The Promoter supports the responsible service of alcohol and the Promotion is at all times subject to the Promoter's responsible service of alcohol policy. The entitlement of Eligible Entrants to receive a Entry Ticket is subject at all times to the Promoter's policies and legal obligations in relation to the responsible service of alcohol. - Participation in the Promotion is open to all persons who meet and continue to satisfy throughout the Promotion Period the details listed in Item 5 as well as the following requirements:
 - a. 18 years of age or older;
 - b. entitled to access the Draw Location;
 - c. not excluded (including an exclusion direction or self-exclusion order) from a casino or premises operated by The Star Entertainment Group Limited (and its related entities); and
 - d. not the subject of a Withdrawal of License (**WOL**) from The Star Sydney, The Star Gold Coast or The Star Brisbane.
- 3. - including entry validating and receipting processes, during the Promotion.
- 13. In the event that a malfunction occurs with Synkros system, the Promoter will extract from the Synkros system all virtual entries earned in accordance with these Terms and Conditions and the draw process will be conducted manually.
