

Terms and Conditions Oasis Hot Seat Draws – December 2024

The following Promotion Details are to be read in conjunction with the Terms and Conditions.

Promotion Details	
Item 1: Promoter	The Promoter is The Star Entertainment Brisbane Operations Pty Ltd ABN 98 608 159 173 of 33 William Street, Brisbane QLD 4000. (the "Promoter").
Item 2: Promotion	Oasis Hot Seat Draws – December 2024 (the "Promotion").
Item 3: Participating Property	The Star Brisbane
Item 4: Promotion Period	The Promotion Period will run from 2.15pm Thursday 26 December 2024 until the conclusion of the 8.15pm Draw on Monday 30 December 2024.
	All times are listed in Australian Eastern Standard Time.
Item 5: Entry Requirement	Participation in the Promotion is open to all persons who satisfy clause 2 of the Terms and Conditions of this Promotion, and who are a select Gold tier Member of The Star Club with an active Membership Card (each an "Eligible Entrant").
	For the avoidance of doubt, Eligible Entrants who:
	 a. migrate to a higher membership tier during the Promotion Period will remain an "Eligible Entrant" so long as they: I. hold a valid Gold tier The Star Club membership or higher for the duration of the Promotion Period, and II. held a valid Gold tier The Star Club membership at the time of Entering the Promotion;
	 relegate to a membership tier which is lower than Gold tier The Star Club membership during the Promotion Period, will be an "Invalid Entrant" and will no longer be eligible to enter or participate in the Promotion and will forfeit any entitlement to a prize.

	If the Eligible Entrants playing the Selected Machined satisfy these Promotion terms and conditions, they will be deemed the "Selected Winner" of a Prize as detailed in Item 11 and will receive a message on the NAMB unit of the Selected Machine they are playing notifying them of their win.
Item 9: Draw Location	Oasis – The Star Brisbane
Item 10: Present at Draws	Not applicable.
Item 11: Prize/s	Each Selected Winner, subject to compliance with these Conditions of Entry, will win \$250 Casino Dollars (each a "Prize").

Casino Dollars

Casino Dollar Prizes will be loaded to the Member's account by the Promoter. Casino Dollars may become temporarily unavailable at any time due to reasons outside of the control of the Promoter such as technical or system issues.

Casino Dollars will expire if at least one (1) Tier Point is not accrued at least once every 180 days.

The Star Club

Any Member found to be in breach of The Star Club membership terms and conditions of use, including participation or knowledge of fraudulent activity such as purposely participating with another Member's Membership Card, is subject to consequences determined by The Promoter and The Star Club terms and conditions. The Promoter reserves the right to review and utilise all property resources available, including security and CCTV footage, if a Member is suspected for fraudulent or undesirable use of a Membership Card that calls into question the validity of any Prize won.

Terms and Conditions

- The Promoter listed in Item 1 will conduct the Promotion listed in Item 2 at the Participating Property listed in Item 3 during the Promotion Period listed in Item 4.

- 14. The Promoter reserves the right to waive or vary the identification requirements specified in these Terms and Conditions in circumstances where the identity of the winner is determinable without the assistance of the specified identification.
