

Terms and Conditions Sovereign Hot Seat Draws – December 2024

The following Promotion Details are to be read in conjunction with the Terms and Conditions.

Promotion Details	
Item 1: Promoter	The Promoter is The Star Entertainment Brisbane Operations Pty Ltd ABN 98 608 159 173 of 33 William Street, Brisbane QLD 4000. (the "Promoter").
Item 2: Promotion	Sovereign Hot Seat Draws – December 2024 (the "Promotion").
Item 3: Participating Property	The Star Brisbane
Item 4: Promotion Period	The Promotion Period will run from 2.00pm Thursday 26 December 2024 until the conclusion of the 8.00pm Draw on Monday 30 December 2024.
	All times are listed in Australian Eastern Standard Time.
Item 5: Entry Requirement	Participation in the Promotion is open to all persons who satisfy clause 2 of the Terms and Conditions of this Promotion, and who are a select Diamond, Platinum or Prestige tier Member of The Star Club with an active Membership Card (each an "Eligible Entrant"). For the avoidance of doubt, Eligible Entrants who:

The Promoter reserves the right to review and utilise all property resources available, including security and CCTV footage, if a Member is suspected for fraudulent or undesirable use of a Membership Card that calls into question the validity of any Prize won.

Terms and Conditions
